Governing Regulations:

1. Values listed in the table do not include the 5% business tax.
2. For overtime use, 50% of the hourly rate is charged when it is less than 30 minutes and 100% of the hourly rate is charged between 30 minutes and one hour.
3. During the move-in/ -out period, the hourly rate is charged at a 40% discount.
4. The lessee of the TAITRA Taipei Nangang Exhibition Center, Hall 2 VIP rooms, Multifunction Meeting Room, and the organizer's office must be the organizer or exhibitor using the exhibition hall, or lessee of at least 50% of Conference Room 701. The organizers and exhibitors on the respective floors of the venue must give Area P 109, Area R 409, and Area S 411 priority for rental.
5. The VIP Rooms shall only be used for receiving VIPs or by news reporters and the lessee shall not alter the layout of existing equipment or allow the consumption of food in the rooms.
6. After finishing using the space above, the lessee is responsible for ensuring that everything is in its original condition before being returned. If there is any property damage or other infringement of rights during the lease period, the lessee shall be held liable for compensation. TAITRA will deduct related repair and compensation costs from the security deposit with the shortage to be supplemented by the lessee.
7. Payment must be made upon confirmation of the event date.

In case of any violation of the aforementioned rules and failure to make immediate corrections after advice has been given, TAITRA shall unilaterally terminate the event and confiscate the collected

payments.

8. The Rental Rates will be adjusted without prior notice, but the fee basis will be according to the fee basis at the time of contract signing.
